



Dear Mare Owner,

We look forward to servicing your mare at Pacific Crest Equine (PCE) for the 2025 Breeding Season. To help us give your mare the best care and to optimize her breeding, please complete the following and return to our office before bringing the mare in or minimum 1 week before ordering semen for breeding services:

1. The completed and signed **Stallion Services Contract** from PCE. Please retain a copy of the contract for your own records.
2. The completed and signed **Credit Card Authorization Form**. If there is no credit card filled in, shipment may be denied.
3. The **Stallion Information/Shipping Sheet**.
4. A copy of your mare's **registration papers**, both front and back. Please include 5 panel genetic test results.
5. Indicate how you will be listed as a **breeder** on the Stallion Reports (i.e., your name or a ranch name).
6. A **\$650.00** chute fee and appropriate stallion fee. A check may be made payable to Rocking BS ranch for your **stallion fee** and included in the envelope with this contract. All checks for **Chute Fee** can be made payable to Pacific Crest Equine.

## Stallion Service Contract

I, \_\_\_\_\_ as owner of the MARE, \_\_\_\_\_, Registration # \_\_\_\_\_ Breed: Quarter Horse, hereby agree to contract with **Pacific Crest Equine**, hereinafter known as “breeder”, to breed to the stallion **Annie's Smart Cat**, Registration # 5784172, owned by Rocking BS Ranch, during the 2025 breeding season, which begins February 1, 2025 and end July 1, 2025. Subject to the following terms and conditions: Breeding fee of \$3150, including a \$650 chute fee, and \$2500 stud fee. Chute fee is non-refundable and due upon execution of this contract and remainder of breeding fee is due prior to breeding of the above stated mare.

Mare owner understand that they must comply with the following when dealing with shipped semen

- **Orders for semen must be made by 4pm PST the day prior to collection/shipment.**
  - Cancellations must be made by 8:00 AM PST the day of shipment.
  - Cancellations after that will be subject to \$100 cancellation fee.
- Please remember this stallion is actively showing throughout the season and there will be blackout dates when fresh cooled semen is unavailable. Frozen semen is available during these time frames (subject to additional fees).

**All contracts must be returned with fees PAID IN FULL and Mare's registration papers submitted prior to any shipment.**

Check all that apply:

- A) My mare will be bred with shipped cooled semen
- B) My mare will be bred on site
- C) My mare will have an embryo transfer performed
- D) My mare will have multiple embryo transfers/ICSI this season

Mare Owner understands and complies with:

1. Mare shall be in a healthy and sound breeding condition. Mare owner agrees to provide a photocopy of the mare's registration papers prior to breeding.
2. Mare owner agrees to have the mare checked by ultrasound and to provide Pacific Crest Equine “PCE” with the results of the pregnancy exam no later than 30 days after the examination of the mare.
3. If the mare aborts or fails to conceive, she may return during the breeding season of the following year **ONLY**, provided all fees have been paid during the 2025 season.
4. Live Foal guarantee: Stallion fee is for one live foal. A live foal is defined as one that will stand and nurse. If the foal is born dead, mare owner agrees to furnish to the stallion owner, within seven (7) days, a veterinarian's certificate describing the occurrence. In such a case, return privileges will be available for one year **ONLY**. Breeding fee will not be refunded.
  - a. If the mare owner fails to return the mare for rebreeding the following year, then any and all fees paid shall be forfeited, the right to rebreed is cancelled and the Stallion owner is released from all further obligations of the contract, unless otherwise agreed in writing and signed by both parties.
  - b. If the mare dies or becomes unfit to breed, the mare owner may return this season or the following season **ONLY** with a substitute mare approved by the stallion owner without any additional breeding fees.
  - c. Owner shall hold stallion Owner and/or PCE harmless for any accident, injury, theft, disease, sickness, or death suffered by the mare and/or foal, or any other cause of action whatsoever arising out of, or connected in any way with shipped semen breeding. This includes but is not limited to, any claims of damages, loss or injury that may occur to any person or personal property.
5. Should the above named stallion die or become unfit for service for any reason, then this contract shall become null and void and both parties are relieved of any further obligation hereunder, and any monies paid by the Mare owner toward the stallion fee, with the exception of the non-fundable Booking and Chute fee, shall be re-funded to the Mare owner if the mare is not settled or would qualify for rebreed privileges.
6. This contract provides for one (1) Breeder's certificate. If multiple embryos are retrieved from one breeding additional contracts and/or breeding fees will be at the discretion of the stallion owner, it will be the responsibility of the mare owner to notify PCE of number transferred. If multiple embryos are desired and it takes more than one breeding, an additional

contract is required for each breeding. Please notify PCE with the status (in-foal/open) of your mare by the end of breeding season. Stallion breeding reports are prepared immediately after the season. If ICSI procedure is used to produce multiple embryos, it will be at the discretion of the stallion owner to determine applicable fees.

- a. If the mare owner desires to do a frozen embryo, it will solely be their responsibility to pay all nomination fees. It is also the mare owner's responsibility to notify PCE when the embryo is frozen and when utilized.
  - b. To obtain a Breeders Certificate you must notify Pacific Crest equine of the birth of the foal. Certificate will not be issued if the account has not been paid in full. The stallion owner is responsible for signing the Breeder's Certificates.
7. Mares on the premises of PCE have a breeding priority on any given breeding day: therefore, we make no guarantee cooled semen will be available for a specific day.
  8. The first 2 pickups/onsite or first FedEx shipment is included in chute fee. In the event that the first shipment is counter-to-counter \$300 will go toward the shipment fees. Mares on site at PCE, first two-cycles are included in fees. The remainder is payable prior to the shipment leaving custody of **Pacific Crest Equine**.
    - a. New Contract: The first semen shipment will be paid to PCE (Courier Fee not included) All subsequent shipments, if necessary, must be paid in advance by the mare owner at \$350.00 per shipment, plus any air courier fees.
    - b. Rebreds/Donated Breedings: All shipments must be paid in advance by the mare owner at \$350.00 per shipment. A container usage fee must also be paid in advance for the current year.
    - c. On-site mares: Chute fee covers all rectal palpation, ultrasound, semen collection, and artificial insemination for 2 cycles if necessary. In the event that more breeding attempts are required, after the first two, the Mare Owner is responsible for all charges associated. Additional costs, including daily care and feed, treatments, and medical care are at the Mare Owner's expense and subject to change based upon the mare's needs. All fees must be paid before mare leaves the PCE premises.
  9. Any subsequent pickups or shipments must be paid in advance, or will be charged to the credit card on file, no shipment will be released without prior payment. \*Pricing listed above.
  10. A Semen Shipment includes the cost of the collection and evaluation of the semen and the shipping (i.e. FedEx or Counter to Counter airline.) In addition to the agreed Booking and Chute fee, Balance of the Stud fee, and Container Usage Fee, additional semen shipment charges may apply (#12-16).
  11. PCE only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during any after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. PCE does not guarantee the fertility of any stallion but agrees to process each ejaculate to optimize 24-hour post cool motility and subsequent fertility. Every effort should be made to inseminate the mare within 24 hours after collection from the stallion. Mare owner agrees to use all cooled semen provided by the agreement for the mare named in the Agreement and no other.
  12. Courier fees: Counter to Counter Airline shipments will be subject to an additional fee.
  13. Due to anticipated high demand for shipped semen, it is imperative that the container be returned to PCE within 5 days. Any containers not returned within 5 days will be charged a \$25.00 per day late charge. Late charges will be charged to the mare owners account and must be paid prior to any subsequent shipments. The shipping container and all its components must be returned complete and in good condition. If any of the components (i.e. coolant cans, ballast bags, etc.) are damaged or missing the cost of replacement will be charged to the Mare owner's account. Should the Mare owner fail to return the container, the Mare owner agrees to pay its value of \$250.00.
  14. HERDA Statement: Hereditary equine regional dermal asthenia (HERDA) is a genetic skin condition predominantly found in the American Quarter Horse. HERDA is an autosomal recessive gene, meaning its inheritance affects mares and stallions in equal proportions. Annies Smart Cat has been DNA tested and is a carrier (N/HRD) of this disease. It is the policy of the stallion owner Rocking BS Ranch to not breed HERDA carriers to each other due to a 25% chance of producing offspring clinically affected by the disease. It is strongly recommended that all mares being considered for breeding to the above-named stallion be tested for HERDA prior to execution of this contract. Rocking BS Ranch will not assume liability or financial responsibility, including breeding service fees, if a carrier (N/HRD) mare is bred to Annies Smart Cat. Please call Pacific Crest Equine for any additional information.
  15. Stallions are collected on **Monday, Wednesday, Friday**. It will be the responsibility of the Mare Owner and his/her veterinarian to confirm our breeding days.
  16. You must give advance notice to PCE (559)972-5555 -OR- (559) 592-4753 4pm PST the day prior to actual shipment. All shipments cancellations must be made by 8:00AM (PST/PDT) the day of shipment. **DO NOT ORDER SEMEN VIA EMAIL**. You must receive verbal or text confirmation from a PCE employee to order semen.
  17. In the case of subsequent shipments, the shipping container and any additional shipping fees (see above) must be received by PCE before the next shipment will be sent.
  18. Every effort will be made to accommodate your mare's time frame. However, it is the Mare owner's responsibility to contact PCE, so that your veterinarian and ours can get your mare in foal on a timely basis.
  19. The Mare owner agrees to comply with all appropriate Breed Registry requirements concerning the use and handling of cooled semen. Consequently, it is the Mare owner's responsibility to return the signed Semen Collection/Insemination Certificate to PCE, and forward a signed copy of the certificate to the appropriate Breed registry.
  20. Failure to adhere to these requirements may result in missed heats, and delayed shipments **AT THE MARE OWNERS EXPENSE**. Insemination must be done by a veterinarian knowledgeable in successful insemination techniques.

21. If it should become necessary for PCE to retain the services of an attorney to enforce its rights under the terms of this contract, including but not limited to collection of any sums due, the Owner will pay PCE all expenses and costs, including reasonable and necessary attorney's fees incurred by PCE in enforcing this contract.
22. Any dispute related to this contract will be governed by the laws of the State of California and venue of any dispute arising from this Contract shall be in Tulare, County, CA.
